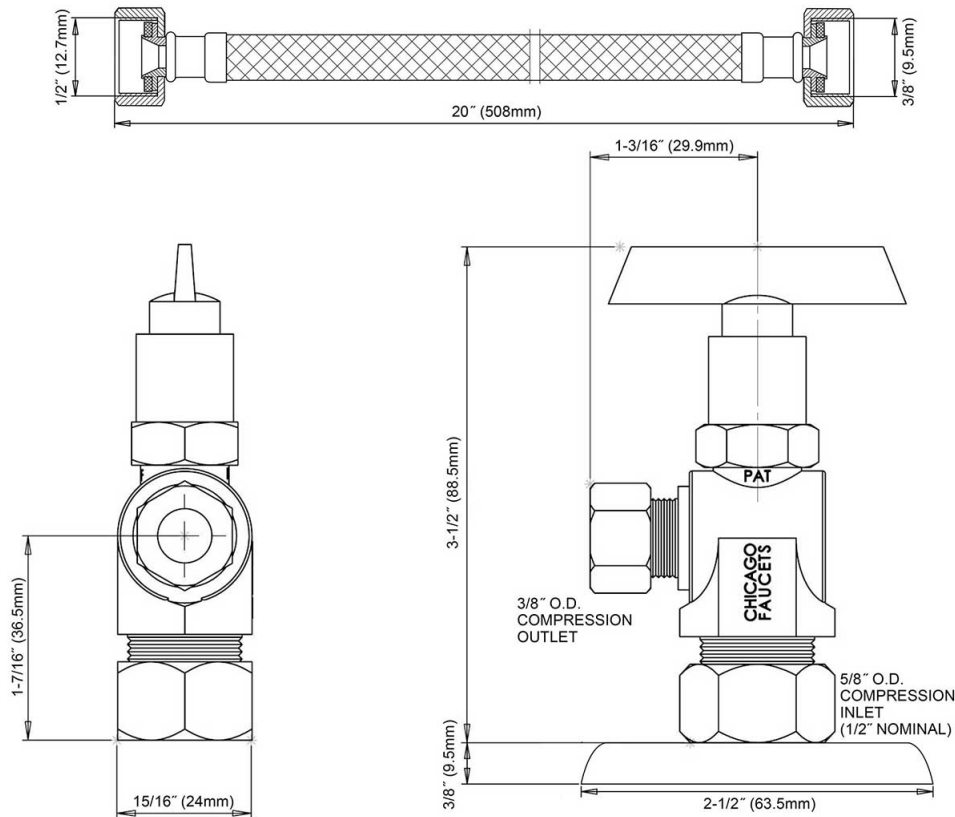

Chicago Faucets No. STB-31-13-PR-AB, Angle Stop Fittings (one pair) with ball valve, supply hose, and loose key handle. Chrome plated. 5/8" O.D. (1/2" nominal) female compression inlet. 3/8" O.D. female compression outlet. Slip wall flange. Flexible, stainless steel hose with 3/8" x 1/2" female compression fittings. ECAST® construction with less than 0.25% lead content by weighted average. This product is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, Certified to NSF/ANSI 61, Section 9 by CSA, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.



Operation and Maintenance
