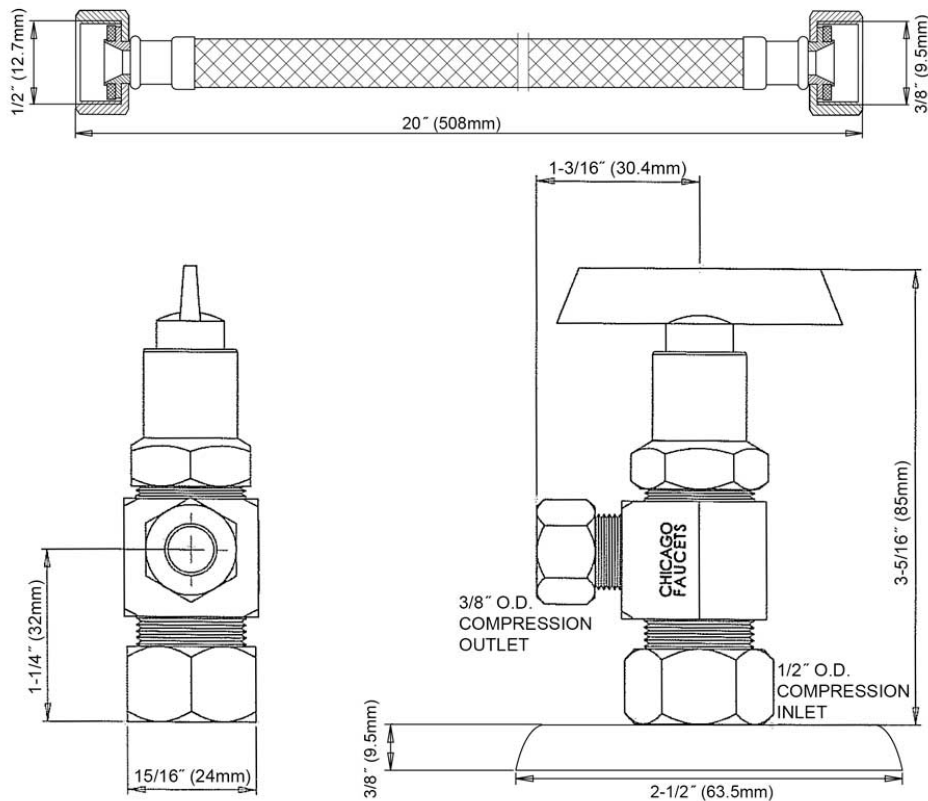

(1/2" nominal) female compression inlet. 3/8" O.D. female compression outlet. Slip wall flange. Flexible, stainless steel hose with 3/8" x 1/2" female compression fittings. ECAST® construction with less than 0.25% lead content by weighted average. Operation and Maintenance
