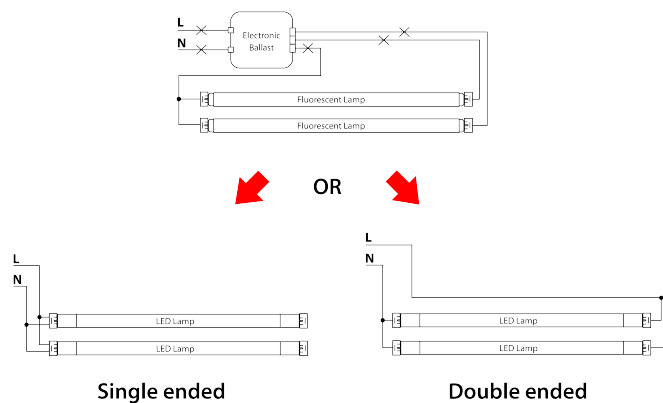

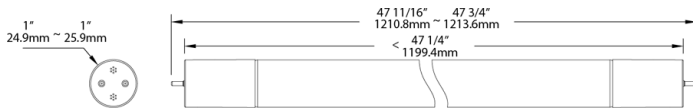
## Wiring Diagram
